'LA PERRIERE' TERMS AND CONDITIONS

Effective from 2004

Lets commence On Saturdays.

The Gite is available to you from 4pm and needs to be vacated by 10am on the day of your departure.

Bed linen/towels can be provided on request.

Linen is charged at 8 - 00€ per bed, per week and a set of towels (bath and hand towel) is charged at 5 - 00€ per person, per week. Tea towels are provided free of charge.

Linen and towel charges, if required, are to be paid in Euros at the commencement of the holiday

All prices include gas, water, and electricity, except October to April when there is an additional charge of 20 - 00€ per week for La Petite Perriere, which is to be paid in Euros at the commencement of the holiday

A booking deposit of 25% is required. The balance of the payment is due eight weeks before the start of the holiday and this is to include the refundable security deposit of (£100). This deposit, against breakages and final cleaning, is payable in advance and is fully refundable, assuming no damage to the Gite, its contents or any item associated with the Gite holiday property has occurred.

The Gite will be available to you cleaned and ready for your occupancy at our stated time on your requested arrival date, and it is expected that upon your departure, that you will ensure that it is left in the same condition. If in our opinion the Gite, or any towels / linen has been left in a "less than clean" condition, then we reserve the right to deduct the additional cleaning / replacement costs from your security deposit.

A Gite inventory of all items provided for your use will be given to you on your arrival and this will be used as a measure for any breakages etc. It is in your interests to check this inventory at the start of the holiday. Any breakage, damage, or cleaning charges will be deducted from the security deposit and the balance returned in the form of a personal cheque, within ten days after your departure.

In line with new EEC pool safety / security regulations, the swimming pool is enclosed within a fenced area with a special key lockable access gate. It is your responsibility to ensure that when you are not on the premises and at the end of the day, this gate is locked. All children must be kept under close supervision at all times within the confines of the pool area.

For your and the safety of your children, we have provided plastic glasses and plates for use by your children around and within the pool area. Please ensure that children are not allowed within the pool or its enclosed area with any form of "glass containers.

Outside of the Gite area & garden, our land ranges from flat grassland through to ancient woodland to river frontage and rock face and all of this is available for your enjoyment and exploration, but please note, that in places low voltage electric fencing is used for animal containment. Please ensure that you take the necessary care required.

Holiday insurance against cancellation is advisable, as holidays are payable in advance.

Normal household insurance has been taken out by the owners, but guests are requested to ensure they are covered for any additional insurance they may feel necessary.

In addition to the facilities provided, we offer cycle hire and horse riding / tuition. For both these activities we do not provide accident insurance and strongly suggest that if you consider participating in either, that you ensure that your standard holiday insurance covers you for any possible accidents that may occur. If your holiday insurance does not cover you, separate cover must be arranged. We will assume that if you decide to participate in either of these activities that you have arranged this additional cover. We provide the required safety helmets but would suggest that you bring jodhpurs / trousers and suitable footwear. Open toed sandals and shorts are not suitable.

Horse / pony riding is considered a hazardous recreational activity.
